The mean value of these programs in the community (33/3), social norms (46/3), national identity (29/3), religious (11/3) e-citizenship and culture (26/3) higher the average level. Average rating scale showed that social norms and Citizen Electronics ranked lowest to highest rating won. The following demographic variables gender, age, education, occupation and marital status were not significant differences in respondents' mean comments.
